

THIS IS A LIMITED WARRANTY.

It applies to: BF Goodrich Advantage TA tires, Mirada Cross Tour tires, and Michelin Defender tires (if the Signature Package was included or purchased) "Signature Warranty Tires".

Five Year Wear Out Warranty*

If your Tireman Signature Warranty Tire wears out* Tireman will install a comparable tire at no charge. The five-year period begins the day of your purchase and ends five years thereafter, regardless of mileage. This warranty applies only to the original owner of the tire.

* Tread Wear Out is Defined as Follows:

According to most states' laws, tires become legally worn out when they reach 2/32" of remaining tread depth (identified when the tread blocks/ribs wear down to the bars molded across their tread pattern). Each tire will be evaluated independently for replacement eligibility.

To make a claim under this warranty, return the covered tire to any Tireman location for warranty service. Note: Proof of proper tire rotation and alignment service is required to enforce the warranty.

What Is Not Covered

- Irregular wear to the tire or tire damage due to vandalism, accident, or fire
- Damage to the tire caused by improper inflation, overloading, or misapplication
- Irregular or premature wear caused by not rotating your tires every 8,000 miles or according to the tire manufacturer recommendations, whichever rotation period is less.

Note: Proof of proper rotation maintenance is required. If your rotations are performed by Tireman, all history will be recorded within the Tireman system. If you have the rotations performed by another facility, documented proof will be required.

- Misalignment or other mechanical defects causing tire damage.
- Parts and labor associated with installing the parts that are necessary to bring the alignment settings into proper vehicle alignment specifications.
- Loss of your time or your inconvenience
- Loss of your vehicle or any consequential damage to you or your property or to others or the property of others
- Commercial or Industrial use of the covered tire

ANY OTHER INCIDENTAL AND CONSEQUENTIAL DAMAGES ARISING FROM THE TIRE WEARING OUT ARE NOT COVERED**

30-Day Ride Comfort Guarantee

If you are not satisfied with your Tireman Signature Warranty Tires any time within the 30 day ride comfort period which begins the day you purchased your Tireman Signature Warranty Tires and ends 30 days thereafter, you should return to a Tireman Auto Service Center for a credit towards a set of comparable tires. The 30-Day Ride Comfort Guarantee applies to purchases of complete sets of four tires on the original purchase. Tires that are purchased individually, or in less than a complete set of four are not subject to the 30-Day Ride Comfort Guarantee. Your remedy is limited to the replacement of comparable tires.

Tire Rotation

We will rotate all of your tires as long as you own them on the original vehicle. We recommend every 6,000 to 8,000 miles.

Tire and Wheel Balancing

We will balance your tires and wheels free of charge during the five year wear out warranty period.

Free Road Hazard Protection

- TIRE REPAIRS. We will repair a punctured tire Free of Charge.
- ROAD HAZARD COVERAGE. If you have a tire that is not repairable, we will replace it Free of Charge during the five year warranty period.

NATIONWIDE COVERAGE. In the event you are 50 miles or more from a Tireman location, have the tire repaired. Or if the tire cannot be repaired, replace it with a comparable new tire. Then bring your replacement tire receipt to any Tireman Auto Service Center and we will refund the cost of replacing that tire up to the original purchase price of the Signature Warranty Tire.

*Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

**Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusion for those damages may not apply to you.

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

By receiving this Signature Loyalty Voucher, you are receiving written assurance that if you purchase Signature Warranty tires from Tireman today and don't have a wear-out replacement, road hazard or repair claim, within the 5-year warranty period, you will receive a \$12.50 per tire credit for each unused Signature Warranty towards the purchase of your next set of [4] Signature Warranty tires.

WHAT IS COVERED?

This voucher only applies to tires that are installed on the vehicle listed on your original invoice and the DOT (Department of Transportation) serial numbers listed on the sidewall of your surrendered tires must match the DOT numbers listed on your original invoice. The 5-year warranty period must have expired and you must surrender these tires in order to receive credit under this program.

You will receive a \$12.50 per tire credit for each unused Signature Warranty towards the purchase of a new set of [4] Signature tires. A new set of [4] Signature tires must be purchased to be eligible for this credit. There is no cash value and no refunds apply.

WHAT IS AN UNUSED SIGNATURE WARRANTY?

An unused Signature Warranty is a warranty that has not been used for wear-out replacement, road hazard or repair claim, within the 5-year warranty period, for a tire listed on your original invoice.

WHERE CAN YOU OBTAIN SERVICE?

The Signature Loyalty Voucher credit can be obtained only at any Tireman Auto Service Center location. The current locations are listed on the web at www.thetireman.com.

WHAT YOU MUST DO TO MAKE A CLAIM:

1. The Tireman receipt covering the original purchase of the eligible tire must be submitted at the time of any claim.
2. You must submit this Signature Loyalty Voucher at the time of any claim.
3. You must surrender the tires matching the DOT (Department of Transportation) numbers listed on the original invoice at the time of any claim.
4. A Tireman representative will verify if unused credits apply using the Tireman database system.
5. The unused credits will be multiplied by \$12.50 (maximum of \$50). This credit will be applied towards the purchase of a new set of [4] Signature Warranty tires.
